

FAIR HOUSING ACRONYMS AND TERMS

The housing industry, like most industries, utilizes a unique set of terms that sets it apart from other groups. As with many terms and phrases that are frequently referenced or subjected to quick and easy abbreviation, acronyms have been developed and are generally substituted for the term or phrase.

The Department of Housing and Urban Development, commonly referred to as "HUD," utilizes an abundance of acronyms in all aspects of its business. Attached is a list of common HUD acronyms often used in regard to "fair housing" and other related housing subject matters.

These acronyms are generally included in various documents, such as training guides, HUD guidance materials, contracts, development proposals, financial analyses, feasibility studies, informational papers and other housing industry-related materials.

The list is not intended to be a comprehensive reference of all HUD acronyms related to fair housing. The list may also include acronyms that are common to other industries, groups or associations.
