Coordinated Street Outreach Program Introduction

- October 14, 2019: City Council accepted the City of San Diego Community Action Plan on Homelessness (R-312700).
- June 8, 2020: City Council took action as part of the Fiscal Year 2021 City of San Diego budget approval to allocate \$1,500,000 for the purpose of providing Coordinated Street Outreach services in the City of San Diego (R-313071).
- June 16, 2020: City Council authorized the execution of a
 Memorandum of Understanding between the City of San Diego and
 the Housing Commission for Homeless Housing Assistance
 Program (HHAP) Block Grant Funded Programs, which including
 the appropriation of \$250,000 to cover a two-year period, for the
 purpose of creating a Senior Outreach Coordinator position that
 would be employed through the Housing Commission (R-313113).





Coordinated Street Outreach Program Introduction (Continued)

Coordinated Street Outreach Program Request for Proposals

- Request for Proposal was issued July 29, 2020.
- 1,943 notifications were sent though the PlanetBids system.
- 3 proposals were received by the deadline of August 26, 2020.
- SDHC is recommending to award the contract to People Assisting the Homeless (PATH).





Coordinated Street Outreach Program People Assisting The Homeless (PATH)

- 37 years of experience serving individuals experiencing homelessness
- Serving San Diegans since 2013
 - 1,100 people Countywide annually
- Operates Connections Housing
 - City-funded, one-stop supportive service and residential community in downtown San Diego
- PATH San Diego operates a County of San Diegofunded street outreach program
 - Focuses on both engaging and housing unsheltered individuals who were frequent users of the healthcare system
- Developed a successful neighborhood-specific outreach pilot program in 2018

Coordinated Street Outreach Program COVID-19 Precautions

- The initial contract term will be pro-rated for an eight-month period.
- Fiscal Year (FY) 2021 operating contract includes one-time expenditures related to program start-up.
- Option years will be exercised contingent on appropriation of funds by the City of San Diego.





Coordinated Street Outreach Program SDHC Responsibilities

- SDHC shall be responsible for the general management, administration, and oversight of the Coordinated Street Outreach program in the City of San Diego
- SDHC shall collect monthly reporting on program performance metrics and outcomes from the contracted operator and provide regular reporting summaries to the City in a form and format agreed upon by both parties.
- SDHC shall accommodate specialized data requests to meet City needs related to public information provision or grant compliance.





Coordinated Street Outreach Program City Responsibilities

- The City shall provide funding for the \$1,500,000 Coordinated Outreach program from the Homeless Strategies Department General Fund.
- Support for the ongoing operation of the City's "Survey 123" application, currently utilized by all City-funded outreach teams.
- The City shall explore the expansion of the "Get It Done" application to serve as a mechanism to receive, review and refer applicable community requests for outreach services.





Coordinated Street Outreach Program Staff Recommendations

That the Housing Authority of the City of San Diego (Housing Authority) take the following actions:

- Authorize the execution of an agreement with People Assisting The Homeless (PATH) to operate the City of San Diego's (City) Coordinated Street Outreach Program, for a one-year term in the amount of \$1,425,000, with one one-year option to renew at SDHC's sole discretion, in which the initial contract term will be pro-rated for an eight-month period, from November 1, 2020, to June 30, 2021, in the amount of \$1,027,643.
- Authorize SDHC's President & Chief Executive Officer (President & CEO), or designee, to execute all documents and instruments necessary and/or appropriate to implement these approvals, in a form and format approved by General Counsel, and to take such actions necessary and/or appropriate to implement these approvals;





Coordinated Street Outreach Program Staff Recommendations (Continued)

- Authorize SDHC's President & CEO, or designee, to substitute funding sources and/or increase compensation by not more than 20 percent of the total agreement amount for the proposed agreement, if necessary, without further action by SDHC's Board of Commissioners (Board), but only if and to the extent that funds are determined to be available for such purposes; and
- Authorize the execution of a Memorandum of Understanding between the City of San Diego and the Housing Commission for the oversight and administration of the City's Coordinated Street Outreach Program.





Coordinated Street Outreach Program Staff Recommendations (Continued)

That the San Diego City Council take the following action:

- Authorize the execution of a Memorandum of Understanding between the City of San Diego and the Housing Commission for the oversight and administration of the City's Coordinated Street Outreach Program.
- Authorize the Chief Financial Officer to expend funds as outlined in the Memorandum of Understanding for the purpose of executing this agreement, including an amount not to exceed \$1,077,643 in Fiscal Year 2021 from the General Fund Homelessness Strategies Department.




