SUMMARY

This report has been prepared in response to the Housing Authority of the City of San Diego's Resolution Number HA-1569 granting the San Diego Housing Commission (Housing Commission) authority for a number of grant-related activities and requiring submission of a semi-annual report of all grant activity. This report includes information on competitive grants, non-competitive grants and direct allocations to the Housing Commission, and pass-through funds from the City of San Diego. Allocations received for the purpose of responding to the COVID-19 pandemic through June 30, 2021, are included in Attachment A of this report.

Grant Activity – Competitive Grants

During the second half of Fiscal Year (FY) 2021 (January 1, 2021, through June 30, 2021), the Housing Commission received notices of decision for nine grants, totaling more than \$14.8 million. The Housing Commission was awarded four new grants totaling \$9.1 million, and five renewal grants totaling more than \$5.7 million. Below are the details of this grant activity. Sub-recipient agreements executed as a result of these grants are reported in Table 4.

Grant Activity – Non-Competitive/Allocations

As a Public Housing Authority (PHA), the Housing Commission is allocated funds from the U.S. Department of Housing and Urban Development (HUD) based on formulas, and sometimes other factors, to meet its obligations as a PHA. During the second half of Fiscal Year 2021 (January 1, 2021, through June 30, 2021), HUD allocated \$392,293 to the Housing Commission. Below are the details of the allocations and intended uses. Contracts awarded as a result of these funds are reported in Table 6.
