As an MTW agency, the San Diego Housing Commission (SDHC) designs and tests innovative, cost-effective ways of providing housing assistance to low-income families, using a combination of federal funding allocated to SDHC for public housing and Housing Choice Voucher (Section 8) rental assistance.

I would also like to share with you additional important SDHC activities:

SDHC Partnership: New Affordable Housing for Families with Special Needs

California Assembly Speaker Toni Atkins, a longtime voice for affordable housing, helped break ground on a first-of-its-kind development to provide affordable rental housing in the City of San Diego specifically for families with a member who has a developmental disability.

Independence Point, a \$13.5 million development for low- and very lowincome families by Chelsea Investment Corp., is being built with \$8 million in bond financing approved by the San Diego City Council at the recommendation of SDHC.

SDHC also provided a \$2.5 million loan, which consists of \$2.2 million in federal HOME Investment Partnerships Program funds and \$300,000 from the City of San Diego's Housing Trust Fund.


