WHEREAS, the public hearing was held on October 10, 2017, and an opportunity was provided for interested persons to express their views on the issuance of the Bonds and on the nature and location of the Project; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. The City Council, as the applicable elected representative under section 147(f) of the Code, approves the issuance of the Bonds by the Authority.

2. The City does not warrant the creditw	or timess of the Bonds of guarantee, in any
way, the payment of the Bonds. No moneys of the Ci	ty will be pledged or applied to the
