City Homeless Shelters and Services Memorandum of Understanding Overview

The Memorandum of Understanding (MOU):

- Delegates the administration of the City of San Diego's Homeless Services Programs to SDHC.
- SDHC is the recipient of City funds allocated to the Homeless Shelters and Services Programs.
- SDHC enters into operating agreements with sub-recipients, who in-turn provide support services and housing solutions for persons experiencing homelessness within the City of San Diego.
- SDHC staff monitor contract performance, program budgets, and other administrative facets of the programs.



City Homeless Shelters and Services Background

- June 2010: The MOU was approved by the City and the Housing Authority for a term of five years.
- Subsequent amendments clarified programs and funding authorized under the MOU.
- June 2014: The MOU was renewed for another five-year term, with one amendment in April 2015 to:
 - Consolidate all previous amendments into one agreement; and
 - Provide SDHC with additional flexibility to accommodate program changes, as necessary.
- June 30, 2019: The current MOU expires and requires renewal.



City Homeless Shelters and Services

Programmatic Overview

Services Resources:

- Day Center Facility for Homeless Adults
 - Provides basic needs and supportive services
 - Serves a minimum of 6,000 homeless individuals annually
- Transitional Storage Center
 - Provides 400 storage bins for homeless individuals
 - Serves a minimum of 550 individuals annually

City Homeless Shelters and Services Programmatic Overview (Continued)

Interim Housing Resources

- Father Joe's Villages Interim Housing Program
 - Provides 350 interim beds
 - Serves a minimum of 1,390 single adults annually
- PATH Connections Housing Interim Bed Program
 - Provides 150 interim beds
 - Serves a minimum of 450 single adults annually
- Cortez Hill Family Center
 - Provides 47 transitional family units
 - Serves a minimum of 135 families with children annually

City Homeless Shelters and Services Programmatic Overview (Continued)

Transitional Housing Resources

- MHS Serial Inebriate Program Transitional Housing
 - Provides 56 transitional beds
 - Serves a minimum of 145 adults annually

Rapid Rehousing Resources

- PATH Emergency Solutions Grant (ESG) Rapid Rehousing Program
 - Provides temporary rental assistance and benefits
 - Assists a minimum of 80 families annually



City Homeless Shelters and Services

Staff Recommendations

That the SDHC Board of Commissioners recommend that the Housing Authority of the City of San Diego take the following actions:

- Approve a Memorandum of Understanding (MOU) between the City of San Diego (City) and SDHC for the Provision of Homeless Shelters and Services:
 - Initial one-year term of July 1, 2019 to June 30, 2020
 - Four additional one-year options to extend
- Authorize SDHC's President & Chief Executive Officer, or designee, to execute the final negotiated MOU in a form approved by General Counsel and to take all actions necessary to implement these approvals.
