SDHC – Fiscal Year 2020 MTW Annual Plan

What is Moving to Work?

- MTW allows SDHC to design innovative, cost-effective ways of providing housing assistance to low-income families.
- SDHC is one of only 39 public housing authorities, out of 3,400 nationwide, to receive an MTW designation.
- In 2015, Congress directed HUD to expand the MTW demonstration by 100 public housing authorities over seven years.

What is Moving to Work? (Continued)

- Three main objectives of the MTW Program:
 - 1) Achieve greater cost effectiveness
 - 2) Help families make progress toward economic self-sufficiency
 - 3) Increase housing choices for low income families





SDHC – Fiscal Year 2022 MTW Annual Plan Proposed Initiatives

1. Flexible Funding of Supportive Services
2. Funding for SDHC's Homeownership Programs, as needed





SDHC – Fiscal Year 2022 MTW Annual Plan

Proposed Initiatives – Flexible Funding of Supportive Services

Description: This proposal would allow MTW funds to be used in a flexible manner to provide supportive services. Some examples of possible applications could include:

- Providing funding for central case management as clients move between multiple SDHC programs
- Bridging gaps in supportive services that may be encountered during property acquisitions
- Helping families obtain internet access that may be necessary for educational or work opportunities

Goals:

- SDHC can make program operations more efficient by providing a centralized funding resource as a stop-gap measure for supportive services regardless of the program enrollment.





SDHC – Fiscal Year 2022 MTW Annual Plan

Proposed Initiatives – Funding for SDHC’s Homeownership Programs

Description: This proposal would allow MTW funds to be used, as needed, instead of or in addition to existing funding sources, such as the federal HOME Investment Partnerships Program and City of San Diego Inclusionary Housing Funds.

Goals:

- The use of MTW funds provides the opportunity for the current homeownership program to either maintain similar funding levels if other funding sources are reduced or to expand the existing programs in the future.
